How can ordinary people of faith and conscience move from being victims, spectators or pundits to being architects of our community? Andre Stoner is a lead organizer with We Make Indiana. He has over eight years of experience building a multi-racial and multi-faith social justice network in St. Joe County. He was pastor of outreach at Kern Road Mennonite Church for 17 years and worked for Mennonite Church USA as director of holistic witness and interchurch relations.

Dion Payne-Miller is South Bend organizer for We Make Indiana. In April he and a team of Black church leaders brought 250 people together to press the Mayor and City Council to hold negligent landlords accountable. Dion served on the Kern Road church board and calls himself a Mennocostal. He and his wife Tiana recently welcomed their first child into this world.

Renew Your Spirit | Twilla Epp-Stutzman

Chapel

In this summer season of growth, nurture and tend to your inner life through a time of contemplation. Together we will open ourselves to God through the practice of Lectio Divina (a prayerful listening of Scripture). Following the meditative practice, participants will be invited to enter a time of solitude and reflection in available spaces, inside or outside (weather permitting). Optional reflection questions will be provided.

CONSENSUS IS A PROCESS...

Be heard

Listen to understand the others' points of view rather than to prepare your own response. Listen more than you speak.

1

2

Be fully present

Bring your whole self to community discernment. Focus on the process, from beginning to end, and the conversation in your group.

3

Assume best intentions

Is there something someone said that you want to understand better? Be inquisitive. Use curiosity instead of judgments/assumptions.

4

Build understanding

Even more than problem solving or absolute agreement, the goal of discussion is increase understanding between individuals.

5

Examine multiple perspectives

On rare occasions, consensus will be unanimous agreement. For the rest of the time, we will seek a consensus that acknowledges our different views and finds an agreeable future.

ROBERT'S RULES OF ORDER...

Motion

...is the statement of an idea proposed for decision-making

- It can be presented by anyone: "I move that..."
- Or the leader may ask, "Is there a motion to..."

Second

...is a show of support for the motion to be considered

- Anyone can say, "I second the motion"
- Or the leader may ask, "Is there a second?"

Restate

The leader restates the motion so that everyone understands what is being considered

Discussion

Time is given for discussion of the motion

- In table groups with feedback shared with the gathered group

Vote

The leader states the motion then asks for delegates to vote

- The motion will pass if at least 1/2 of the votes are affirmative (in some cases, the MLT may request a higher affirmation percentage for a motion to pass)
- Voting may be done by a show of hands, a verbal affirmation, or ballot

Announce

The leader announces the result of the vote and any instructions

Summer Fest 2025 Minutes and Proceedings

Location: Waterford Mennonite Church (Goshen, IN)

Recorder: Randy Miller, Walnut Hill

Friday, June 13, 2025

Opening Worship

- Steph Wieand (Berkey Avenue) opened the service with words of welcome and a call to worship.
- Led by Tom Good (East Goshen), the congregation sang “Come, We That Love the Lord” (VT 31) and “Come Away from Rush and Hurry” (VT 9). Later in the service, songs included “My Love Colors Outside the Lines” (VT 582), “May You Be Rooted and Grounded in Love” (VT 396), and “Be a Sower” (VT 789).
- Steve Slagel led a roll call to recognize those present.
- Izaete Nafziger (North Goshen) shared a congregational story from North Goshen Mennonite Church.
- Quinn Brenneke (Prairie Street) preached on Crossing Borders, Seeing Jesus, using the text of Ephesians 2:13-22.
- Andrea Dean (administrative coordinator) introduced the evening’s fellowship time, and Steph Wiend closed the service with a blessing.

Social Hour

- Snacks and Conversations: Attendees mingled in informal fellowship.

Saturday, June 14, 2025

Morning Worship

- Ben Bouwman (Walnut Hill) opened the service with words of welcome, a call to worship, and prayer.
- Deron Bergstresser (Waterford) led the congregation in “God, Be the Love” (VT 43) and “You Are Salt for the Earth” (VT 297). Later songs included “What Does the Lord Require” (VT 207), “Beautiful Things” (VT 551), and “Light Dawns on a Weary World” (VT 205).
- Joy Detweiler (Prairie Street) shared the history of the Great Lakes Quilt, pieced by Wanda Bouwman from quilt squares prepared by member congregations of four conferences in 2004.

- Scripture texts were Deuteronomy 24:17–22 and Micah 6:6–8.
- Cindy Voth, Katie Misz, and J.E. Misz (Waterford) shared reflections and poetry from their experiences on the MCC South Texas Borderlands Tour.
- Andrea Dean reviewed the morning schedule, and Ben Bouwman closed the service with a blessing.

Discerning in Community

1. Welcome and Orientation.

- a. Moderator Steve Slagel welcomed all delegates and attenders to a time of not only business but playfulness. Andrea Baker Dean (Administrative Coordinator) gave an overview of the program book. She noted the seminar choices, the Consensus process, and the Items for discussion and action. She thanked those who submitted reports (along with encouragement to actually read them).
- b. Steve introduced the Consensus process and how it works together with Robert’s Rules of Order. “Robert’s Rules is thick and we want to make it thinner.”

2. Words of Welcome from Conference Ministers.

- a. Joanne Gallardo gave words of welcome and gratitude for all in attendance. Sharon Yoder echoed her gratefulness and gave a shout out to Andrea, who came on at the busiest time of the year. She asked the Leadership Team members present to identify themselves.

3. Deceased Pastors.

- a. Sharon shared the names of former pastors who have died in the past year (that we know of): Ray Bair, Jim Gerber, Simon Gingerich, James Horsch, Noah Hochstetler, Ron Kennel, Calvin King, Lee Lowery, and John F Murray.

4. Congregational Update.

- a. Sharon introduced the Muanges, Pastor Simon and Mama Lucy, as they are known, who gave an update on their work with International Bethel Christian Church in Detroit (and internationally) and expressed their gratitude to the people of

God. Sharon offered a prayer of blessing with all arms extended toward them.

5. New Pastor Recognition.

- a. Kent Yoder, chair of Leadership Enhancement Team, named the pastors and leaders new to IMMC during the past year: Teresa Dutchersmith, Jonathan Landis, Peter Martin, Derrick Ramer, Ndunge Sefu, and Ursula Hess; and invited forward those who were present. Barb Slagel, LET member, presented each with a copy of the book *The Space Between Us*, by Betty Pries, and Kent offered a prayer of blessing.

6. Gifts Development Presentation and Vote.

- a. Merle Hostetler, member of Gifts Development Team, introduced the ballot of new leadership team members, identified GDT members, and described their task of matching interests and abilities with sense of call and availability.
- b. Steve invited prayers for the persons named and ballots were distributed.

7. Spending Plan Presentation & Vote.

- a. Jim Alvarez, Stewardship Team chair, introduced ST members and went over the proposed Spending Plan for 2025-26.
 - i. The process starts in late fall, recognizing that adjustments will need to be made.
 - ii. Jim described differences between restricted funds and unrestricted funds and showed the giving trends to Conference over the past five years and year to date.
 - iii. He introduced the 2025-26 Spending Plan, including increases in individual giving and the draw from endowed funds.
- b. Jim and Sharon answered questions about the change from 4% to 5% draws from investments; why some items were increased when last year they were unspent; the purpose of denominational accountability fees of \$5 per minister; why/how the expected increase in individual giving can be so high, and what kind of FTE is going into fundraising.
- c. Steve called for the vote by ballot and led a prayer.

8. Ballot Results

- a. After a short break, Steve announced the ballot results.
 - i. GDT ballots: 54 yes and one abstention
 - ii. Spending plan ballots: 53 yes, including seven comments and suggestions.

9. Approval of Minutes from Summer Fest 2024.

- a. Steve invited affirmation for the minutes from last year's Summer Fest. Marlene Kroeker asked why we bother with this and answered her own question.

10. Generative conversation.

- a. Joanne reviewed the Conference's focus on Growing our Intercultural Witness and invited table groups to respond to questions for discussion:
 - i. What season are you in? A season of rest or action? If so, what kind of action?
 - ii. Describe a time when you have loved beyond borders.
 - iii. How are you feeling about the current climate?
 - iv. How might the church respond to Jesus' call to be in solidarity with those on the margins?
- b. Opportunity was given for sharing with the whole group: Teresa Dutchersmith (Kern Road) affirmed the conversations at their table. Barbara Deveraux (Kern Road) shared that several members at Kern Road also attend services of other persuasions. Katie Misz (Waterford) affirmed the presence of young adults and the value of various ages.

11. Moderator Handoff.

- a. Steve offered reflections on the changes in Conference since he became a pastor in 1999, many that he is glad for: "Laughter has found its way back into what we do."
- b. He invited Becky Helmuth (moderator-elect) forward and gave her a copy of Walter Brueggeman's book *An Ongoing Imagination*. She thanked him for his thoughtful and ornery leadership and noted that "change looks like welcome, like repair," and received her new role as moderator with joy.

12. Discerning in Community session adjourned.

- a. Andrea made several announcements and Becky led a prayer before lunch.

Lunch

- Participants enjoyed lunch prepared by Waterford Mennonite Church.

Seminars

- *The Dream Lives On! Dorothy's Word* – In this seminar, Jacob Elias (formerly Parkview, currently Hively Avenue, Elkhart) featured articles by Dorothy Word (1938-2020), an African-American Mennonite woman who became a guest columnist for the Kokomo Tribune and wrote articles dealing with equity, inclusion, and justice issues.
- *Looking back, living forward: An African woman's recollections of 40 years of a Pietist, Evangelical, Wesleyan, Pentecostal and Anabaptist faith (1985–2025)* – In this reflective session, Sibonokuhle Ncube (Eighth Street, Goshen) shared about various influences on her identity as an ecowomanist who is following the way of Jesus as an obedient pacifist Christian.
- *Eco-Anabaptism at 499: The 'Gospel of All Creatures' and Climate Change* – In this seminar, Douglas Day Kaufman (Assembly) explored the teaching of early Anabaptist eco-mystic Hans Hut and how it can inform and encourage engagement on the ecological crises of our day.

- Derrick Ramer (Benton) opened the service with words of welcome, a call to worship, and an opening prayer.
- Led by Ndunge Sefu (First Indy), the congregation sang "How Great Is Our God" (VT 116) and "The Love of God" (VT 162). Later songs included "Kombo na Yesu (The Name of Jesus)" (VT 648), "God Welcomes All / Amen" (VT 32), and "Sizohamba naye (We Will Walk with God)" (VT 815).
- Art Stoltzfus shared a congregational story from College Mennonite Church.
- Sharon Yoder preached on the Summer Fest theme, Love Has No Borders.
- Joanne Gallardo led a time of communion.
- Andrea Dean named gratitude for all worship participants throughout the weekend, and Derrick Ramer closed Summer Fest with a blessing and sending.

The gathering adjourned at 5:30 pm.

Membership Recommendation for International Bethel City Church

Process

International Bethel City Church (IBCC) is a multicultural church that started in 2004 in Portland, Oregon. They became a member congregation of Pacific Northwest Mennonite Conference where Simon was ordained in 2012. Simon and his wife, Lucy, and their family moved to the Northwest after living in Virginia for three years. Their move to the USA in 1999 from the Democratic Republic of Congo was rooted in a call to service in the USA. In 2021, again following God's call, they moved to Detroit to begin a church plant there. In Detroit, Sharon Yoder, Conference Minister, was in conversations with them, connecting them with MMN's SENT training program. IBCC worships each week at Gateway Church, where they have a warm and supporting relationship with the pastor and congregation, that includes regular times for the congregations to worship together.

Sharon has had regular conversations with Lucy and Simon. In 2023, Ministry Credentialing Team began planning a time to visit and worship with them and their congregation. Between time passing and health issues, that visit didn't happen until November 1, 2025. Sharon Yoder, Dave Janzen, and Suella Gerber were moved by Simon and Lucy's personal stories, the stories of God's calling and leading them, and their faithfulness to God's call.

Simon and Lucy attended IMMC's annual meetings (now SummerFest) in 2022, 2023, and 2025, where they've had a chance to tell some of their story and meet some of our conference's members and pastors.

Membership

The Muanges' ministry with International Bethel City Church began in the DRC. They have served in a number of African and North American settings, primarily with immigrant and refugee families, and some European and Americans. In Portland they met and found a theological home with Mennonites from the Pacific NW Conference.

Recommendation

The IMMC Board and Ministry Credentialing Team are delighted and honored to recommend International Bethel City Church as a member congregation of Indiana-Michigan Mennonite Conference.

Proposed 2026-27 Spending Plan

Commentary on the Spending Plan from the Stewardship Team:

As you review data from July 1, 2025 - April 30, 2026, please note:

- **Investment Income**
 - Total actual income includes \$15,000 that was taken from investment funds in October to improve cash flow, due to income shortage in the past two years.
 - On April 30, actual income not including this withdrawal from investments was \$230,772, and actual expenses were \$237,505. Without the \$15,000 from investments, the balance as of April 30 would be a shortfall of \$6,733.
- **weGive Contributions**
 - We made concerted efforts to reach our goal of increasing donations from individuals (weGive) more than threefold, to \$58,000, in this budget year. While we didn't reach this goal, individual donations have more than doubled in the first 10 months of this year compared to the same time a year ago.
 - On April 30, total income from individual donations was \$26,569.
 - We celebrate 17 new donors during these 10 months.
 - **We are deeply grateful for the fundraising contacts made by volunteer Randy Miller** in the past 7 months and for his commitment to continue this work in the coming months.

Looking ahead to the 2026-27 Spending Plan:

- We are presenting a balanced spending plan, with income and expenses both projected to increase by 2%.
- **Expenses**
 - Total salaries, wages, and benefits increased by about 4%, following MC USA pastoral salary guidelines.
 - Adjustments were made in other areas of the spending plan to keep the overall increase in expenses to 2%.
- **Income**
 - Congregational giving has increased slightly in the past 15 months, causing us to project a 4% increase in congregational giving for 2026-27. **We invite congregations who are able, to increase their giving by 2 to 4%.**
 - **We invite ongoing financial partnership from individuals** as we continue to support pastors and leaders in our community of congregations. **You are invited to visit our [weGive page](#) to learn more about giving options and/or plan now to respond during our upcoming weGive week, June 15-19.**

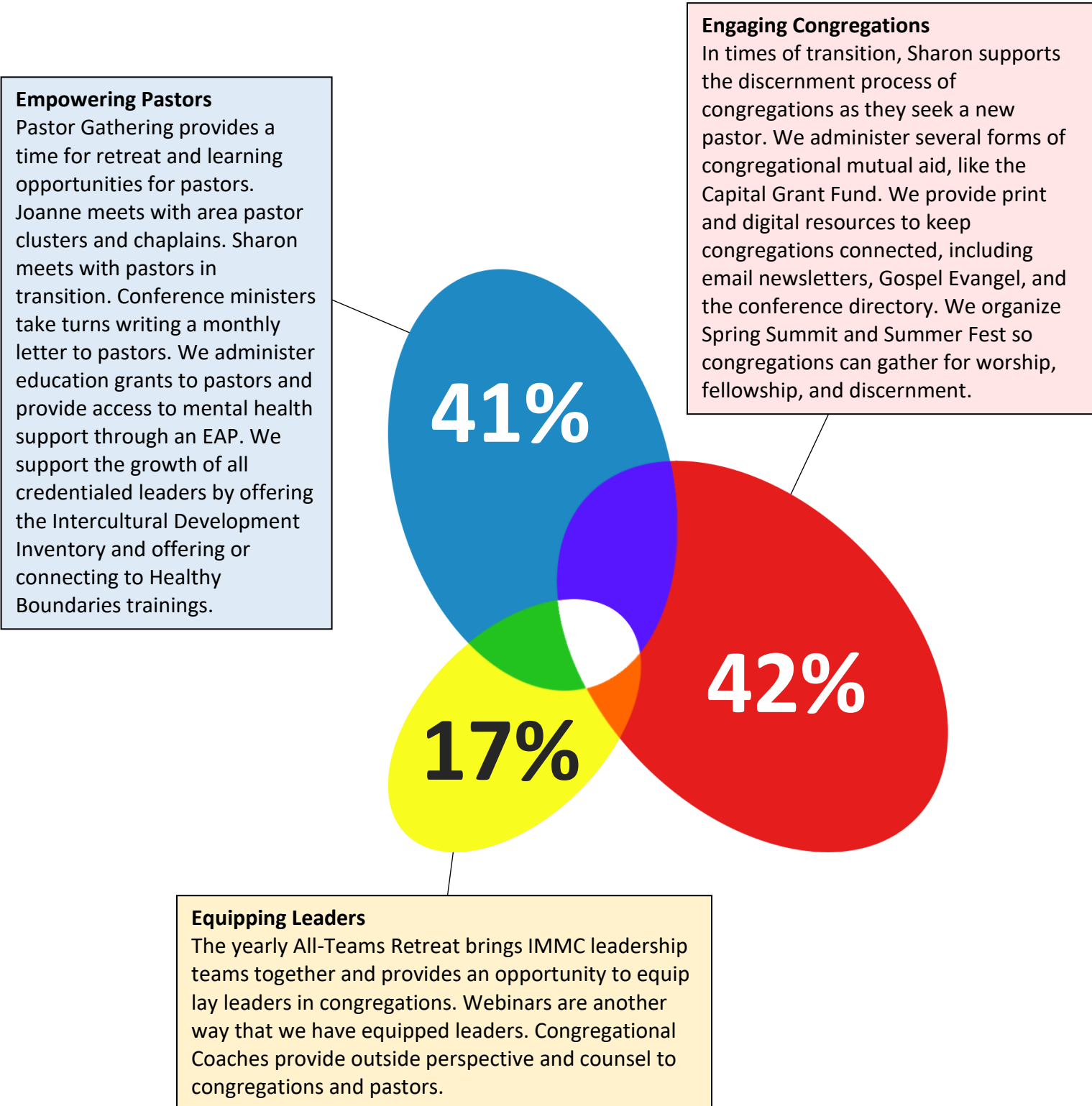

As with other service organizations and many congregations, IMMC’s expenses are mostly related to staffing. The staff help to carry out the work of the organization by providing services directly to congregations and pastors as well as coordination for our volunteer leadership teams and board.

The descriptions below cover much but not all of IMMC’s work—and there is much overlap between these categories.



Chapter 3: Reports to Delegates 2025-26

Conference Board Report

This year brought a change in name and clarity of purpose for our conference leadership. After hearing that “Missional Leadership Team” was often confusing, we adopted the name Conference Board, while continuing to understand our work as missional leadership on behalf of the delegate body.

Amos 5:24 shaped our year: Let justice roll down like waters, and righteousness like an ever-flowing stream. This is IMMC's conference-wide focus, carried through our August board retreat in Conway, Michigan, our All-Teams Retreat in September, Spring Summits in March, and sustained conversations about intercultural competence and how the conference can better support congregations, pastors, and leaders.

Conference Minister Joanne Gallardo offered Intercultural Development Inventory conversations with pastors and leaders across the conference. The board participated in immigration-related events, continued reparations conversations, and invested in partnerships that invite us to listen more carefully to the Spirit's movement in our communities. This work is ongoing and unfinished.

At our Spring Summits in March, we recommended International Bethel City Church as a new member congregation of IMMC. Simon and Lucy Muange have offered faithful ministry through IBCC, and we receive their presence in this conference as a gift.

The board reviewed financial reports throughout the year, approved the proposed spending plan, and received a clean financial review. We are grateful for Michelle's careful bookkeeping and the Stewardship Team's faithful stewardship of conference resources. We also began sabbatical planning for Conference Ministers Joanne Gallardo and Sharon Yoder.

As we look ahead, we continue to ask whether our structures, finances, gatherings, and relationships are clearing the way for justice to flow or standing in its path. We are grateful for the congregations, teams, pastors, staff, and delegates whose faithfulness makes this conference what it is.

Conference Staff Report

- we-Give week (Jun 16-20), Giving Tuesday (Dec 2), Year-End (Dec 31), and April donation drives – emails invited partnership with IMMC vision and mission, with the goal of growing IMMC’s individual donor base. We celebrate 17 new donors and increased giving from ongoing donors during the 2025-2026 fiscal year!
- Christmas Open House – connected with 20 guests over snacks in the fellowship hall at East Goshen Mennonite Church on December 18, 2025.
- Pastors Gathering – twenty pastors joined the retreat at Amigo Center November 17-19, bringing good energy to times of fellowship, worship, and leadership development sessions led by Dave Sutter. Pastors also enjoyed time for rest and personal renewal.
- Spring Summits 2025 – held in person at North Goshen Mennonite Church March 14 and via zoom March 21. Pastor Sean Swanson, from Kern Road Mennonite, preached on our theme from Amos 5:24.

Leadership Enhancement Team Report

Leadership Enhancement Team (LET) met regularly throughout 2025-26 to support pastoral wellness, leadership development, congregational coaching, and conference-wide collaboration. Meetings opened with Scripture and prayer, grounding the team's work in shared spiritual reflection.

A major focus this year was strengthening **pastoral support and accountability**. LET and Ministry Credentialing Team (MCT) held a joint meeting in January to clarify roles: MCT provides accountability for credentialed leaders, while LET focuses on development, encouragement, and wellness. Both teams affirmed the value of annual joint meetings and ongoing collaboration. LET will continue using its Growth & Wellness Form, while MCT revises its own accountability tools.

Planning for Pastor Gathering was a large part of LET's work. The 2025 Pastor Gathering centered on the theme *Gifts to the Pastor*, with Dave Sutter facilitating an Open Forum model and LET members leading worship. LET worked on schedule, registration, honorariums, and promotion to ensure a meaningful and well-supported retreat experience. For 2026, the team has confirmed a focus on *Spiritual Direction and Spiritual Practices*, led by Nina Lanctot.

LET also reviewed and strengthened the **Pastoral Education Grant**, increasing the maximum award to \$500 and updating the form to simplify priorities and reflect current needs. The team affirmed the importance of accessible continuing education, including possibilities such as retreats and spiritual direction.

The **Congregational Coaching** program remained an area of attention. LET discussed coach engagement, accountability, and the need for clearer expectations. Plans are underway for a fall 2026 coach resourcing session. **Sister Church** relationships continue to grow, with ongoing discernment around new pairings.

Throughout the year, LET contributed to **conference communication**, preparing weLink updates, promoting Pastor Gathering, highlighting Sister Church opportunities, and preparing the LET report for Summer Fest. LET also selected *Sabbath as Resistance* as the annual gift for new pastors and leaders.

Leadership Enhancement Team remains committed to nurturing healthy, well-supported pastoral leaders and strengthening the spiritual and organizational life of IMMC.

Ministry Credentialing Team Report

Persons who have served on MCT in the past year are Barbara Devereaux, Suella Gerber, Dave Janzen, Linda Thomas, and Phil Waite. Sharon Yoder attends as IMMC Conference Minister and Christina Litwiller takes minutes.

The Ministry Credentialing Team continues to work on credentialing leaders, encouraging all credentialed persons to grow, and offering support so they thrive in their ministry contexts. This year:

1. We met for conversation with persons seeking licensing or ordination. These are holy conversations as we learn to know and affirm those who have been called by their faith communities to serve in congregational ministry, chaplaincy, and other ministering positions.
2. We welcomed new ministries into IMMC: International Bethel City Church, Detroit, and their pastors Lucy and Simon Muange; and Lynette Hartzman, director of Shammah Outreach / B Light Restoration Center, Flint.
3. We partnered newly licensed leaders with peer mentors to walk with them in the first two years of ministry.
4. We revised and updated our job description to reflect our work as well as our intentions and the culture we seek to create.
5. We talked about accountability, what it means for MCT to be accountable to credentialed persons and congregations, and for credentialed persons to be accountable to MCT/IMMC. We're considering how we might ask for accountability that seeks to offer support.

IMMC delegates have tasked MCT with the work and accountability of credentialing leaders. We work to support our pastors and leaders and help them be effective in their placements. It is our hope and intention to create healthy structures and patterns of relationship for pastors and leaders to be “centered on Jesus; guided by the Holy Spirit; acting through grace, love and peace; and engaging the world God loves.”

In addition, we value our collaboration with congregations and recognize the work of the Spirit that makes them loving communities who serve Christ and one another.

Personnel Resourcing Committee Report

Committee Members: Kathy Nofziger Yeakey agreed to be the committee chairperson following Ray Hunsberger’s departure, Sue Ramseyer serves as recorder for committee meetings, and the conference gifts committee is seeking a third member for this committee. Sharon Yoder, Conference Minister, and Michelle Cabanaw, senior bookkeeper, join the meetings.

The Personnel Resourcing Committee (PRC), formerly called the Personnel Committee, met several times in 2025 to review the Employee Handbook for IMMC staff, which had not been officially revised since 2022. In spring 2026, the committee has continued working with Sharon and Michelle to update terminology and bring the handbook into compliance with standard practices. Michelle is a member of the Good Steward Church Academy and has gained much insight into standard employment practices from this organization. Once the Handbook has been updated, it will be submitted to the IMMC Board for approval. In addition, the committee reviewed a Sabbatical Proposal for Joanne Gallardo and recommended it to the Board.

Personnel Resourcing Committee duties include advising on personnel policies and procedures as well as compensation and benefits. The PRC serves as a resource for staff evaluations, reviews and pre-approves sabbatical proposals for staff, and reports to the IMMC Board.

Stewardship Team Report

During the past year, the Stewardship Team (ST) met once in person and 9 times via zoom. Team members in the past year have been Jim Alvarez (chair), Marlene Kroeker, Jeff Miller, and Duane Yoder (IMMC treasurer). Justin Hochstetler joined us in February. Sharon Yoder, Conference Minister, and Michelle Cabanaw, senior bookkeeper join ST meetings.

The Stewardship Team (ST) is tasked to oversee conference finances and participate in strategic plans and programs to ensure that conference resources are focused on accomplishing conference vision. This includes review of investments, financial reports, spending plan, and fundraising and networking.

Historically, conference congregations have fully supported conference services. Given that this is no longer true, ST has given increased attention to fundraising and networking in the past year, working to diversify funding sources. To grow IMMC’s individual donor base, ST supported conference staff in weGive Week, Giving Tuesday, and Year-End giving campaigns and in developing a fundraising letter and a list of persons to receive the letter, sent in May 2025. Follow-up phone calls and visits will be scheduled in summer 2025. In the past 6 months, Marlene and Sharon met with leaders of two congregations to nurture connections and invite increased financial partnership. Additional congregational contacts will be made in the coming months. ST also updated A Case for Support of IN-MI Mennonite Conference and reviewed a new document developed by staff: Give to IMMC.

Several months ago, ST reviewed investment performances and chose to keep IMMC investments in their current portfolios. ST also reviewed and made recommendations to MLT regarding IMMC’s investment policy. In May, ST reviewed and recommended to MLT a capital grant request from Sunnyside Mennonite Church for \$10,000.

Ongoing work for ST includes review of financial reports and future spending plans, to ensure that finances are on track with the plan and that the new plan matches the vision and capacity of conference. At the end of April 2025, conference income was \$11,000 higher and expenses were \$6000 lower than in April 2024. Traditionally, May and June have shown strong income, and we anticipate some return from fundraising efforts in these months. This points to a stronger ending to this fiscal year than last.

We are deeply grateful for generous financial partnership that makes it possible for conference staff to continue equipping and supporting IMMC's community of congregations as they engage the world God loves.

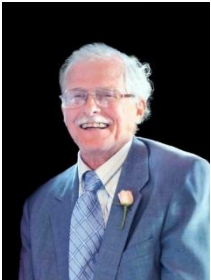
